3. I do not have any direct personal, business, financial or other interest in the application or the staff from SRK.
4. I have studied the Draft Scoping Report. My main interest is in the protection and mitigation of impacts on the Surface- and Groundwater and here are comments for further consideration:
  - a. Refer to Par 8 of the Executive Summary: *"Specialists will be required to provide detailed baseline information and to identify and assess the potential impacts of the proposed project within their particular field of study. In addition, specialists will be required to identify practicable mitigation and optimisation measures to avoid or minimise potential negative impact and/or enhance any benefits."* These specialists also needs to propose suitable monitoring programmes to continuously assess the impacts during operational and closure phases.
  - b. Refer to Par 8 of the Executive Summary: Delete second "you": **HOW YOU CAN YOU PARTICIPATE IN THE EIA PROCESS**
  - c. Par 3.8.4: The 2<sup>nd</sup> option for return water recovery Penstock intakes – not viable as this alternative requires gravity feed; This needs to be relouked. The topography allows for gravity feed. The reason not viable . What is permeability of the material to be deposited?
  - d. Par 3.9.1.2: "60 Mm" should be "60 Mm<sup>3</sup>"
  - e. Par 3.9.2.4: "Both the internal and external slopes of the walls will be constructed at approximately 26.6° (1:2)," . To be motivated or reconsidered.
  - f. Par 3.10.1: "Top 5cm of topsoil will be harvested with bulldozers before mining takes place ...." ??? It is common practice to strip at least 150mm+ topsoil. Can "windrow" it with a grader but not a bulldozer.
  - g. Par 3.10.5.2: Sand tailings will have 20% moisture content at disposal. This is seawater. The RAS tailings were also processed with seawater. This means that the total salt deposit in the eastern mining area is estimated between 100 000 – 150 000tons???

- h. Refer to Par 4.1.8.3. If “Regionally, the water table contours mimic topography” then there is reason to believe that recharge is from rainfall.

**COMMENT ON THE DRAFT SCOPING REPORT AND PLAN OF STUDY FOR ENVIRONMENTAL IMPACT ASSESSMENT FOR THE INTEGRATED ENVIRONMENTAL AUTHORISATION APPLICATION FOR THE MODIFIED EAST ORANGE FELDSPATHIC SAND PROJECT RESIDUE DISPOSAL PLAN ON PORTIONS 1 AND 2 OF THE FARM HARTEBEESTE KOM NO. 156, THE REMAINDER OF PORTION 1 OF THE FARM GRAAUWDUINEN NO. 152, PORTION 1 AND THE REMAINING EXTENT OF RIETFontein EXTENSION NO. 151, AND PORTION 5 OF FARM HOUTKRAAL NO. 143, BRAND-SE-BAAI (PROJECT NO: 548215/3)**

The e-mail notification of 18 June 2020 regarding the availability of the Draft Scoping Report ("DSR"), and the DSR and Plan of Study for Environmental Impact Assessment ("EIA") that was downloaded from the website of the environmental assessment practitioner, refer.

Please find comment from various directorates within the Department on the DSR and Plan of Study for EIA dated June 2020.

1. Directorate: Development Management (Region 1) – Mr Rainer Chambeau ([Rainer.Chambeau@westerncape.gov.za](mailto:Rainer.Chambeau@westerncape.gov.za); Tel: (021) 483 2729):
  - 1.1. A copy of the Screening Report generated from the National Screening Tool must be included in the Final Scoping Report ("FSR") to be submitted to the competent authority.
  - 1.2. Your attention is drawn to Government Notice ("GN") No. 650 of 5 June 2020: Directions regarding measures to address, prevent and combat the spread of COVID-19 relating to National Environmental Management Permits and Licences set out in the Schedule in terms of regulation 4(10) of the Regulations issued in terms of section 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002) ("the Directions"). The Directions stipulate that all new applications under Alert Level 3 where a public participation process ("PPP") as contemplated in Chapter 6 of the EIA Regulations, 2014 (as amended) is required, is subject to an agreed public participation plan. A copy of the agreed public participation plan must be included in the FSR and the Draft EIA Report.
  - 1.3. It is noted that the applicant is in possession of an environmental authorisation ("EA") granted in March 2012 for the East Orange Feldspathic Sand ("OFS") project. The DSR states that the EA for the East OFS project authorised the development of three smaller residue storage facilities ("RSFs"); however, subsequent engineering studies conducted by the applicant concluded that these facilities are neither operationally practical, nor sufficient for the management of the fine residue from the East OFS ore body. A single RSF is now proposed for the controlled disposal of all fine residue that will be generated by the East OFS project. Please note that if the EA (assumedly granted by this Directorate during March 2012) is still valid, then an amendment to the EA would be required for the exclusion of the three smaller RSTs, following the granting of an EA for a single RSF by the relevant competent authority.
  - 1.4. The response of Heritage Western Cape ("HWC") on the Notification of Intent to Develop submitted in terms of section 38 of the National Heritage Act, 1999 (Act No. 25 of 1999), must be included in the FSR to be submitted to the competent authority. Should HWC require any assessment such as a heritage, archaeological or palaeontological impact assessment, the Plan of Study for EIA must be amended accordingly to include the undertaking of the specified specialist assessment.
  - 1.5. Proof of the public participation process (PPP) undertaken and copies of all comments provided on the DSR must be included in the FSR to be submitted to the competent authority.
2. Directorate: Biodiversity and Coastal Management – Ms Mercia Liddle ([Mercia.Liddle@westerncape.gov.za](mailto:Mercia.Liddle@westerncape.gov.za); Tel: (021) 483 8341):
  - 2.1. This Directorate will provide comment on the application when the Draft EIA Report is released for public consultation.

3. Directorate: Waste Management – Mr Etienne Roux ([Etienne.Roux@westerncape.gov.za](mailto:Etienne.Roux@westerncape.gov.za); Tel: (021) 483 8378):
- 3.1. The specified activities referred to in Table 2 of the Executive Summary of the DSR are listed in Category B of GN No. 921 of 29 November 2013 (as amended), promulgated in terms of section 19(2) of National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008), and not in Listing Notice 1 (of the EIA Regulations, 2014 (as amended)). Table 2 further incorrectly states that a Basic Assessment process is required. Please note that waste management activities listed in Category B of GN No. 921 (as amended), must be subjected to a Scoping and Environmental Impact Reporting process.
4. Directorate: Pollution and Chemicals Management – Mr Gunther Frantz ([Gunther.Frantz@westerncape.gov.za](mailto:Gunther.Frantz@westerncape.gov.za); Tel: (021) 483 2975):
- 4.1. This Directorate recommends the lining of the two proposed sand tailing facilities ("STFs") to prevent the leaching of any pollutants into the groundwater. Consideration of the design and lining material should be provided in the next phase of the application. The design of the STFs should also investigate the addition of a leachate management system to manage any leachate that may arise from the two STFs.
- 4.2. This Directorate recommends the lining of the RSF to prevent the leaching of any pollutants into the groundwater. Consideration of the design and lining material should be investigated in the next phase of the application. The design of the RSF should also investigate the addition of a leachate management system, to manage any leachate that may arise from the RSF. Groundwater monitoring should be incorporated into the conceptual design of the RSF.
- 4.3. This Directorate supports the inclusion of a Surface Water Impact Assessment and a Hydrogeology Impact Assessment in the Plan of Study for EIA.
5. Directorate: Air Quality Management – Ms Gavaza Mhlarhi / Mr Peter Harmse ([Gavaza.Mhlarhi@westerncape.gov.za](mailto:Gavaza.Mhlarhi@westerncape.gov.za); [Peter.Harmse@westerncape.gov.za](mailto:Peter.Harmse@westerncape.gov.za); Tel: (021) 483 8343):
- 5.1. The DSR indicates that the proposed development may result in impacts related to noise and the generation of dust and vehicle exhaust emissions. The Environmental Management Programme to be submitted with the Draft EIA Report must provide management measures to prevent or mitigate noise and air quality impacts.
- 5.2. In this regard, the proposed development must comply with the following:
- 5.2.1. National Environmental Management: Air Quality Act No. 39 of 2004 ("NEM: AQA");
- 5.2.2. National Dust Control Regulations (GN No. R. 827) of 1 November 2013, promulgated in terms of the NEM: AQA; and
- 5.2.3. Western Cape Noise Control Regulations (Provincial Notice 200/2013) of 20 June 2013.
