## DRAFT BASIC ASSESSMENT REPORT AVAILABLE FOR PUBLIC REVIWE AND COMMENT

SRK Consulting was appointed by BVI Consulting Engineers on behalf of the Department of Water and Sanitation DWS) as the independent Environmental Assessment Practitioner to undertake the necessary Environmental Authorisation processes, and associated stakeholder engagement for the proposed project.

A Basic Assessment (BA) in terms of the NEMA to be submitted to the Department of Environmental Affair (DEA) and a Water Use Licence Application (WULA), in terms of the National Water Act (Act 36 of 1998) (NWA), to be submitted to DWS, for all the remediation and rehabilitation, which will be undertaken.

This project entails the remediation and rehabilitation interventions required on the banks and floodplain of the river. The proposed interventions will address the erosion and bank instability along the river. The remediation and rehabilitation will take place on the following farm portions mentioned below,


