Notice is hereby given in terms of the Environmental Impact Assessment (EIA) Regulations, amended on 7 April 2017, promulgated in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA), that Anglo American Platinum's Rustenburg Base Metals Refiners (RBMR) is applying for an Environmental Authorisation (EA) for the proposed relocation of the bulk chemical storage facility at RBMR, North West Province.

ENVIRONMENTAL AUTHORISATION PROCESS:
