

Motivation for the Postponement of Compliance Timeframes in terms of Regulation 11 of Section 21 NEM:AQA Minimum Emission Standards, for Sasol South Africa (Pty) Ltd. Operations in Sasolburg

COMMENT AND RESPONSE REPORT

This Comments and Response Report (CRR) records the comments expressed by Interested and Affected Parties (I&APs) during the Public Participation process followed for of the Sasol South Africa (Pty) Limited (Sasol) Operations in Sasolburg.

Comments were received in writing (comment forms, online comment forms, emails, faxes and letters), as well as verbally, during telephonic communication and at the public meetings held on 21 and 22 February 2017, at Vaalpark Primary School, Boiketlong Community Hall and at the Zamdela Multi-Purpose Centre.

It should be noted that the public meetings for the Natref and Sasol Sasolburg Operations postponement application were held jointly. In the interest of transparency, all comments made during the meetings are reflected in the CRR. Therefore, while the CRR pertains specifically to the Sasolburg Operations applications comments on the Natref application made during the public meetings are also captured and responded to here.

2.1	Mr. Raubenheimer noted that he was previously employed at Natref, and is concerned over air quality within the Vaal Triangle – highlighting that his children do cough a lot more when in Sasolburg than when elsewhere. Furthermore noting that if Sasol has spent over R20 billion on technology to improve emissions, why then are emissions still so high? He noted that there is technology available to control PM, and queried why it is still such a problem in the area? He also indicated that numerous technology options addressing particulates are installed on site and are being considered to address particulate emissions from site, however that due to the age of the thermal oxidation plant specifically, the particulate emissions are still higher than the minimum emission standards.</p> <p>Mr. van Zyl noted that various alternative technologies are currently being considered to address particulates from the incinerators – however that space constraints are a concern.</p> <p>Further to the response provided at the public meeting, it is noted that in terms of the AIR, Sasol's and Natref's contribution to PM concentrations in the airshed are low (below 16 and 8 % respectively). 
